

## **SUMMARY ANNUAL REPORT FOR NEW ALBERTSON'S INC HEALTH AND WELFARE PLAN**

This is a summary of the annual report of the New Albertson's Inc Health and Welfare Plan (Employer Identification Number 20-4057706, Plan Number 502), for the plan year January 1, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

New Albertson's Inc has committed itself to pay certain medical, prescription drug, and dental claims incurred under the terms of the plan.

### **Insurance Information**

The plan has insurance contracts with Aetna Life Insurance Co, Blue Cross Blue Shield of Illinois, Gerber Life Insurance Company, Standard Insurance Company, Vision Service Plan and Pre-Paid Legal Services Inc DBA LegalShield to pay certain dental, health, HMO contract, accidental death and dismemberment, long-term disability, life insurance, vision and legal services plan memberships claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$21,625,635.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2020, the premiums paid under such "experience-rated" contracts were \$11,723,344 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$10,492,774.
