

Bonding, Adoption and Foster Care Leave for Delaware Associates

INCOME REPLACEMENT

DE PFML

Delaware Paid Family and Medical Leave

- DE PFML provides benefit payments to eligible associates who need take time off work to bond with a child, including adopted and foster children.
- DE PFML allows eligible associates to take up to 12 weeks of paid leave per 12 months to bond with a new child.
- DE PFML pays associates up to 80% of your weekly wage, with a maximum weekly benefit of \$900.
- Use available sick pay first, then available FTO, PTO or vacation to top off your weekly pay to no more than 100% of your full wages.

Bonding, Adoption and Foster Care Leave for Delaware Associates

An eligible associate can take up to twelve (12) weeks off from work for bonding with a new child welcomed into the family within the past 12 months through birth, adoption or foster care.

You may be eligible for job protection for up to 12 weeks under FMLA and DE PFML. This means your original position or an equivalent one will be made available when you return provided your leave does not exceed the permissible amount.

While you are on an approved leave, your income may be replaced by DE PFML for up to 12 weeks. DE PFML pays up to 80% of your weekly wage, up to \$900 per week.

Bonding, adoption and foster care leave can be taken all at once or can be split over a 12-month period.

ELIGIBILITY FOR INCOME REPLACEMENT

To qualify for DE PFML benefits, you:

- Must have worked for Albertsons Companies for at least 12 months and for at least 1,250 hours in the 12 months before your leave begins.

ELIGIBILITY FOR JOB PROTECTION

Family Medical Leave Act

- To be eligible for job protection, you must have worked for Albertsons Companies for at least 12 months and for at least 1,250 hours in the 12 months before your leave begins. FMLA runs concurrent with DE PFML.

- To be eligible for job protection, you must have worked for Albertsons Companies for at least 12 months and for at least 1,250 hours in the 12 months before your leave begins. DE PFML runs concurrent with FMLA.
